Legal Update

Augustin v. City of Philadelphia

In a case that affects many Pennsylvania municipalities, a federal court ruled that Philadelphia Gas Works violated the due process rights of landlord property owners by failing to provide adequate notice of liens filed on rental properties where tenants had not paid their bills. In Augustin v. City of Philadelphia, Philadelphia landlords initiated litigation against PGW in the U.S. District Court for the Eastern District of Pennsylvania to challenge and enjoin PGW from imposing liens on their properties for unpaid utility bills incurred by their tenants. The landlord plaintiffs averred that because the first notice they received of PGW's intent to lien their real estate came shortly before the liens were actually imposed, and in many instances, years after the charges were incurred and the tenants departed, that procedure violated their constitution due process rights under the Fourteen Amendment. To state a claim for due process relief, plaintiffs must establish that they were deprived of a right secured by the Constitution or U.S. laws, and that the alleged deprivation was committed under the color of state law. In its defense, the city asserted that the Due Process Clause does not require a pre-lien notice or a pre-lien hearing before the imposition of a lien for unpaid municipal gas service, and that due process is satisfied by the procedures provided under the Municipal Claims and Tax Liens Act.

In ruling against the city, the court initially noted that the placement of a lien against real property constitutes a "sufficient taking of property" so as to warrant due process protection. The court held that because "notice and hearing must be provided at a meaningful time and in a meaningful manner, in situations where the State feasibly can provide a pre-deprivation hearing before taking property, it must do so regardless of the adequacy of a post-deprivation remedy to compensate for the taking." The court found that PGW offered no explanation as to why it would be impracticable to notify property owner landlords of its customers' delinquencies within such time as would allow the landlords to investigate and take steps to hold their tenants accountable before their account arrearages reached the level where liening is appropriate. The court ruled that PGW's methods do not meet the fundamental requirements of due process. The city has indicated that it plans to appeal the ruling.

Customer Service 101

An easy way to assist your constituents is to facilitate their ability to pay their bills. By providing more payment options, your municipality will not only be providing better customer service, but may also be increasing the amount of money that is coming in.
